<b>KEY TO FDA USE-IN-PREGNANCY RATINGS .....</b>	<b>2350</b>
The Food and Drug Administration's Pregnancy Categories are based on the degree to which available information has ruled out risk to the fetus, balanced against the drug's potential benefits to the patient.
